



Schengen Visa for Medical Treatment (South Sudanese)

Please note:

- For a stay not longer than 90 days
- Additional documents may be requested by the Embassy.
- Applications are treated within 15 days but might take 30 days in special cases and for certain nationalities. Applicants should apply in person with TLScontact (external service provider).
- Visa fee is due upon introduction of the application and is currently € 80 (to be paid through the external service provider TLScontact in Uganda Shillings).
- Children between 6-11 pay €40
- Fees are non-refundable

Requirements:

All Applicants must submit the following (Original plus One Photocopy):

- 1. One **Schengen Visa Application Form** duly completed and signed by applicant.
- 2. **One biometric identical color passport size photograph** (3.5 cm x 4.5 cm) not older than six months.
- 3. **Passport** not older than 10 years, valid for at least three months after intended return journey. The passport must have at least two empty pages.
- 4. Copy of passport bio-data page and copies of all previous Schengen visas and residence permits
- 5. **Letter from South Sudanese doctor and hospital** stating the current health status and confirming that current health conditions requires medical treatment abroad (original and one copy).
- 6. **Official letter from a recognized hospital** in Kampala, confirming the current health status and diagnosis for the treatment in Germany.
- 7. **Official letter from the Medical institute in Germany** confirming time, duration and the estimated costs of the treatment (original and one copy).
- 8. **Official letter from the Medical institute in Germany** confirming that the full amount of money for the treatment has already been transferred (original and one copy).
- 9. **Proof of regular income and financial status** (e.g. salary slips or bank statements of least the last 3 months) or formal obligation letter from Germany. Dependents have to provide documents of the husband / parents.
- 10. Working and granted leave certificate (original and one copy). Dependants have to provide documents of the husband / parents.
- 11. Hotel reservation (in-patient treatment needs to be confirmed by the Medical Institute in Germany).
- 12. **Travel itinerary, self-written** indicating your travel dates, destinations, point of entry or exit and duration in the Schengen area (please note that an airline reservation/ticket are not required).

- 13. **Proof of medical insurance** for the duration of stay with minimum cover of Euro 30.000 (original and one copy).
- 14. **Diplomatic and official passport** holders do not need to submit documents stated under the points 9. / 10. but must present a Verbal Note of the Ministry of Foreign Affairs and International Cooperation of the Republic of South Sudan and original Verbal Note from the Embassy of the Republic of South Sudan in Kampala stating the purpose of the trip and the place and intended duration of the trip.

PLEASE BE ADVISED THAT SUBMITTING ALL REQUIRED DOCUMENTS IS NOT A GUARANTEE THAT A VISA WILL BE GRANTED AND THAT A VISA IS NO GUARANTEE OF ACCESS TO THE SCHENGEN TERRITORY.

THE FINAL DECISION REMAINS WITH THE IMMIGRATION OFFICE AT THE BORDER. THE PERMISSION TO ENTER THE SCHENGEN TERRITORY MAY DEPEND ON THE PRESENTATION OF THE INVITATION LETTER, THE <u>ORIGINAL</u> FORMAL OBLIGATION, YOUR FINANCIAL MEANS AND THE TRAVEL HEALTH INSURANCE.
